Personal data that we process

Gebr. van den Eijnden BV processes your personal data because you use our services and/or because you have provided these to us yourself. Below you find an overview of the personal data that we process:

- First and last name, Gender, Data of birth, Place of birth, Address details, Telephone number, E-mail address, Bank account number.

Special and/or sensitive personal data that we process

Our website and/or services does not intent to collect data about website visitors who are below the age of 16. Unless they have consent of parents or guardian. However, we cannot check whether a visitor is older than 16. Therefore, we recommend parents to be involved in the online activities of their children, in order to prevent that data about children is being collected without parental consent. If you are convinced that we have collected personal data about a minor without this consent, please contact us via info@movers.nl and we will remove this information.

For what purpose and on what basis do we process personal data

Gebr. van den Eijnden BV processes your personal data for the following purposes:

- Completing your payment.
- Sending our newsletter and/or advertising brochure.
- To call or e-mail you if this is necessary to provide our services.
- To inform you about changes to our services and products.
- To deliver goods and services to you.
- Gebr. van den Eijnden BV also processes personal data if we have a legal obligation thereto, such as data that is required for our tax return.

Automated decision making

Gebr. van den Eijnden BV does not make decisions based on automated processing on matters that can have (significant) consequences for people. This concerns decisions that are made by computer software or systems, without human intervention (such as an employee of Gebr. van den Eijnden BV).

How long do we store personal data

Gebr. van den Eijnden BV does not store your personal data any longer than is strictly necessary to realise the purposes for which your data is collected.

Sharing personal data with third parties

Gebr. van den Eijnden BV does not sell your data to third parties and only provides this if this is necessary to execute our agreement with you or to comply with a legal obligation. We conclude a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Gebr. van den Eijnden BV remains responsible for these processing activities.

Cookies, or similar technologies, that we use

Gebr. van den Eijnden BV uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone with your first visit to our website. Gebr. van den Eijnden BV uses cookies with a purely technical functionality. These ensure that the website is working correctly and that, for example, your preferred settings are remembered. These cookies are also used to make the website function correctly and to be able to optimise this. In addition, we place cookies that keep track of your browsing habits, so we can offer tailor-made content and advertisements. We have already informed you about these cookies and requested permission to place these when you first visited our website. You can cancel the cookies by setting up your internet browser so that it will no longer store any cookies. In addition, you can also remove all information that has been stored previously via the settings of your browser. Accessing, adjusting or removing data

You have the right to access, correct or remove your personal data. In addition, you have the right to revoke any permission for processing data or to object to the processing of your personal data by Gebr. van den Eijnden BV and you are entitled to data portability. This means that you can submit a request to us to send the personal data that we have from you in a computer file to you or another organisation mentioned by you. You can submit a request to access, correct, remove, data transfer of your personal data or request to revoke your permission or objection to the processing of your personal data to info@movers.nl. To make sure that the request for access has been made by you, we ask you to also send a copy of your proof of ID. Black out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but at least within four weeks. Gebr. van den Eijnden BV would also like to point out that you have the option to submit a complaint to the national supervisory body, the Data Protection Authority.
